## SPECIFICATIONS

One year's requirements beginning from date of bid approval, for recapping, spotting and section repairing of tires for the Lenawee County Road Commission equipment, F.O.B., Adrian, Michigan.

Tire dealers bidding on tire recapping, spotting or section repairing must furnish with their bid, full specifications of the cap to be used, along with pictures of tread design by tire size.

Recaps shall meet Bandag Precured Retread specifications or approved equal.

Bid price shall include the cost of pickup and delivery two (2) times each week of all tires to be serviced, to the Adrian Garage, 2461 Treat Highway, Adrian, Michigan. Tires will be given to successful bidder off the rim with no tube. No fuel surcharges will be paid for delivery of tires.

Bidder will not submit a bid on recapping, spotting or section repairing without furnishing a guarantee for same.

This bid may be extended or renewed from year to year by the Road Commission at the same prices if agreeable with the successful bidder.

Each successful bidder will be required to execute a "customer – supplier" agreement with the Road Commission detailing the expectations and course of dealing expected of both the supplier and the Road Commission. The agreement shall be in a form selected by the Road Commission. Copies of a sample customer – supplier agreement may be obtained at the Lenawee County Road Commission office at the above address.
